Symptom

The eDocument Framework is a solution to manage electronic documents that have legal compliance aspects. The eDocument country-specific solutions are all built on top of this framework. This note lists all the necessary notes for the installation of the eDocument Framework. To enable the eDocument Framework to a particular country, you must additionally install the notes related to that country.

The eDocument Full solution requires that you implement the SAP ERP, option for e-document processing add-on. This add-on has a limited runtime usage right for the Application Interface Framework (AIF). Please note that you need a separate license for the add-on. For more information, refer to the SAP Note 2378414 or contact your SAP Account Executive. In addition, you must subscribe to SAP Cloud Platform Integration to handle the communication scenarios.

The country Full Solutions enable end-to-end processing of electronic documents and do not require additional implementation of transmission scenarios. You can find more information on each country announcement and installation notes.
